## Ongoing advice



From this, the **Sustainable Portfolio** series was born.

Our Sustainable Portfolios not only incorporate a high ethical benchmark, they also follow strict investment principles:



We choose easy to understand, liquid, quality investments when we create our portfolios.



We design portfolios based on long-term averages, not short-term attempts to predict which markets will do well or not.



We invest in the main types of assets, shares, property, bonds and cash.



Where possible, we avoid high-cost active managers and use low-cost, index-type managers which meet our strict criteria.



Our portfolios are broadly diversified – with the bulk being overseas – spread across many countries. Investing in a range of asset types increases returns and reduces risk.

# Our portfolio series

Our innovative range of sustainable investment portfolios are curated using extensive research and are constantly improved.



## Sustainable<sup>PLUS</sup> portfolio series

These portfolios are designed for people who want to avoid certain types of investments, and also actively support and invest in sustainably-focused companies. They powerfully combine our low-cost index-based approach (which keeps costs low) and our selected 'active' funds (which favour companies that actively support the United Nations Sustainable Development Goals). Although these funds have slightly higher annual costs, there is no compromise to their long-term returns.



## Sustainable portfolio series

These portfolios use low-cost index-type ethical funds. They have a strong focus on financial sustainability, while they also cover key social and energy-use values. The portfolios are well diversified with a low annual cost.
